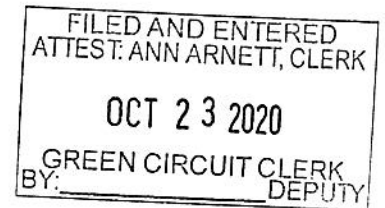

Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 2:

The Grand Jury charges: That on or about August 6, 2020, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possesses: a controlled substance that is classified in Schedules I or II and is a narcotic drug; a controlled substance analogue; methamphetamine; lysergic acid diethylamide; phencyclidine; gamma hydroxybutyric acid (GHB), including its salts, isomers, salts of isomers, and analogues; or flunitrazepam, including its salts, isomers, and salts of isomers or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 3:

The Grand Jury charges that on or about August 6, 2020, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed drug paraphernalia or aided, abetted or counseled with another in said act. Said act against the peace and dignity of the Commonwealth of Kentucky.

COUNT 4:

The Grand Jury charges: That on or about August 6, 2020, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed marijuana or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 5:

The Grand Jury charges: That on or about August 6, 2020, in Green County, Kentucky, the above-named defendant an operator of any vehicle upon a highway shall operate the vehicle in a careful manner, with regard for the safety and convenience of pedestrians and other vehicles upon the highway or aided, abetted or counseled with another in said act. 
