Said act was against the peace and dignity of the Commonwealth of Kentucky.

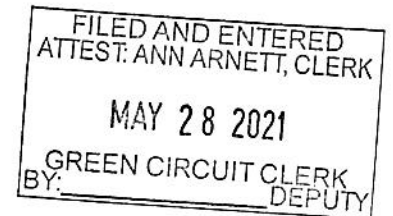

Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 2:**

The Grand Jury charges: That on or about April 21, 2021, in Green County, Kentucky, the above-named defendant while operating a motor vehicle with intent to elude or flee, the person knowingly or wantonly disobeys a direction to stop his or her motor vehicle, given by a person recognized to be a police officer and at least (1) of the following conditions exists: the person is fleeing immediately after committing an act of domestic violence as defined in KRS 403.720 the person is driving under the influence of alcohol or any other substance or combination of substance in violation of KRS 189A.010; the person is driving while his or her driver's license is suspended for violating KRS 189A.010; or be fleeing or eluding, the person is the cause, or creates substantial risk, of serious physical injury or death of any person or property; or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 3:**

The Grand Jury charges that on or about April 21, 2021, in Green County, Kentucky, the above-named defendant who has not applied for an operator's license or whose operator's license has been denied, canceled, suspended, or revoked, or whose privilege to operate a motor vehicle upon the highways while the license is denied, canceled, suspended, or revoked or his privilege to operate a motor vehicle is withdrawn, or the license has not been applied for or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 4:**

The Grand Jury charges: That on or about April 21, 2021, in Green County, Kentucky, the above-named defendant failed to indicate the intention to turn right or left shall be given continuously for not less than the last one hundred feet (100) feet traveled by the motor vehicle before the turn or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 5:**

The Grand Jury charges: That on or about April 21, 2021, in Green County, Kentucky, the above-named defendant was operating a motor vehicle upon the highway carelessly or aided, abetted or counseled with another in said act. The Grand Jury charges: That on or about April 21, 2021, in Green County, Kentucky, the above-named defendant was operating a vehicle upon a highway at a greater speed than is reasonable and prudent, having no regard for the traffic and for the condition and use of the highway or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

The Grand Jury charges that on or about March 3, 2021, in Green County, Kentucky, the above-named defendant under circumstances manifesting extreme indifference to the value of human life, he wantonly engages in conduct which creates a substantial danger of death or serious physical injury to another person or aided abetted or counseled with another in said act.

Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 5:**

The Grand Jury charges that on or about March 3, 2021, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed a controlled substance that is classified as a Schedule I or II, (**Methamphetamine**) which is a narcotic drug, this is the second offense, or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 6-7:**

The Grand Jury charges that on or about March 3, 2021, in Green County, Kentucky, the above-named defendant under circumstances manifesting extreme indifference to the value of human life, he wantonly engages in conduct which creates a substantial danger of death or serious physical injury to another person or aided abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 8:**

The Grand Jury charges that on or about March 3, 2021, in Green County, Kentucky, the above-named defendant, having no right to do so or any reasonable ground to believe that he/she has such right, he/she intentionally or wantonly defaces, destroys or damages any property causing pecuniary loss of \$1,000 or more or aided, abetted or counseled with another. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 9:**

The Grand Jury charges that on or about March 3, 2021, in Green County, Kentucky, the above named defendant, as a pedestrian and with intent to elude or flee, knowingly or wantonly disobeyed a direction to stop given by a person recognized to be a peace officer, and at least one (1) of the following conditions exists: the person is fleeing immediately after committing an act of domestic violence as defined in KRS 403.720; or and by fleeing or eluding, caused or created a substantial risk of serious physical injury or death to any person or property or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 10:**

The Grand Jury charges that on or about March 3, 2021, in Green County, Kentucky, the above-named defendant shall not operate or be in physical control of a motor vehicle while his or her license is revoked or suspended under this chapter, or upon the conclusion of a license revocation period pursuant to KRS 189A.340 unless the person has his or her valid ignition interlock license in the person's possession and the motor vehicle or motorcycle is equipped with a functioning ignition interlock device as required by KRS 189A.420 or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 11:**

The Grand Jury charges: That on or about March 3, 2021, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed drug paraphernalia or aided,

abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 12:**

The Grand Jury charges that on or about March 3, 2021, in Green County, Kentucky, the above-named defendant was operating a motor vehicle anywhere in this state: having an alcohol concentration of 0.08 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the influence of alcohol; while under the influence of any other substance or combination of substances which impairs one's driving ability; while the presence of a controlled substance listed in subsection (12) of this section is detected in the blood, as measured by a scientifically reliable test, or tests, taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the combined influence of alcohol and any other substance which impairs one's driving ability; or having an alcohol concentration of 0.02 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle, if the person is under the age of twenty-one (21) or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 13:**

The Grand Jury charges: That on or about March 3, 2021, in Green County, Kentucky, the above-named defendant intentionally prevents or attempts to prevent a peace officer, recognized to be acting under color of his official authority from effecting an arrest of the actor or another by: using or threatening to use physical force or violence against the peace officer or another; or using any other means creating a substantial risk of causing physical injury to the peace officer or another or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 14:**

The Grand Jury charges: That on or about March 3, 2021, in Green County, Kentucky, the above-named defendant failed to maintain required insurance or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 15:**

The Grand Jury charges: That on or about March 3, 2021, in Green County, Kentucky, the above-named defendant (a) recklessly, with a deadly weapon or dangerous instrument, or intentionally caused or attempted to cause physical injury to another being 1 a state, county, city or federal peace officer; 2 An employee of a detention facility, or state staff secure facility for residential treatment which provides for the care, treatment, or detention of a juvenile charged with or adjudicated delinquent because of a public offense or as a youthful offender; 3 An employee of the Department for Community Based Services employed as a social worker to provide direct client services, if the event occurs while the worker is performing job related duties; 4 Paid or volunteer emergency medical services personnel certified or licensed pursuant to KRS Chapter 311A, if the event occurs while personnel are performing job-related duties; 5 A paid or volunteer

member of an organized fire department, if the event occurs while the member is performing job related duties 6 Paid or volunteer rescue squad personnel affiliated with the Division of Emergency Management of the Department of Military Affairs or local disaster and emergency services organization pursuant to KRS Chapter 39F, if the event occurs while personnel are performing job related duties; 7 A probation and parole officer; 8 A transportation officer appointed by a county fiscal court or legislative body of a consolidated local government, urban-county government, or charter government to transport inmates when the county jail or county correctional facility is closed while the transportation officer is performing job related duties; 9 A public or private elementary or secondary school or school district classified or certified employee, school bus driver, or other school employee acting in the course and scope of the employee's employment; 10 A public or private elementary or secondary school or school district volunteer acting in the course and scope of that person's volunteer service for the school or school district. OR (b) Being a person confined in a detention facility, or a juvenile in a state residential treatment facility or state staff secure facility for residential treatment which provides for the care, treatment or detention of a juvenile charged with or adjudicated delinquent because of a public offense or as a youthful offender, inflicts physical injury upon or throws or causes feces, or urine, or other bodily fluid to be thrown upon an employee of the facility; OR (c) Intentionally causes a person, whom the actor knows or reasonably should know to be a peace officer discharging official duties, to come into contact with saliva, vomit, mucus, blood, seminal fluid, urine, or feces without the consent of the peace officer or aided, abetted or counselled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 16:**

The Grand Jury charges that on or about March 3, 2021, in Green County, Kentucky, the above-named defendant failed to have registration plate conspicuously upon the rear of the motor vehicle or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 17:**

The Grand Jury charges that on or about March 3, 2021, in Green County, Kentucky, the above-named defendant failed to have the receipt issued by the cabinet through the county clerk constantly in his possession or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 18:**

The Grand Jury charges that on or about March 3, 2021, in Green County, Kentucky, the above-named defendant failed to have vehicle when on a highway shall be so equipped as to make a minimum of noise, smoke or other nuisance, to protect the rights of other traffic and to promote the public safety or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 19:**

The Grand Jury charges: That on or about March 3, 2021, in Green County, Kentucky, the above-named defendant disregarded stop sign or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 20:**

The Grand Jury charges: That on or about March 3, 2021, in Green County, Kentucky, the above-named defendant an operator of any vehicle upon a highway shall operate the vehicle in a careful manner, with regard for the safety and convenience of pedestrians and other vehicles upon the highway or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 21:**

The Grand Jury charges: That on or about March 3, 2021, in Green County, Kentucky, the above-named defendant was improper turning or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 22:**

The Grand Jury charges: That on or about March 3, 2021, in Green County, Kentucky, the above-named defendant was operating a vehicle upon a highway at a greater speed than is reasonable and prudent, having no regard for the traffic and for the condition and use of the highway or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 23:**

The Grand Jury charges: That on or about March 3, 2021, in Green County, Kentucky, the above-named defendant failed to have the proper registration plate or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 24:**

The Grand Jury charges: That on or about March 3, 2021, in Green County, Kentucky, the above-named defendant failed to display the registration plate conspicuously upon the rear the motor vehicle or aided, abetted or counseled with another in said act. Said act was against the peace dignity of the Commonwealth of Kentucky.

**COUNT 25:**

The Grand Jury charges: That on or about March 3, 2021, in Green County, Kentucky, the above-named defendant is over the age of 21 and stood convicted of at least two felonies after his 18<sup>th</sup> birthday **OR** one (1) or more felony sex crimes against a minor as defined in KRS 17.500, and now stands convicted of any one (1) or more felonies. 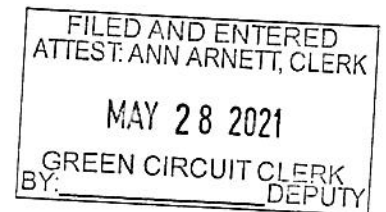

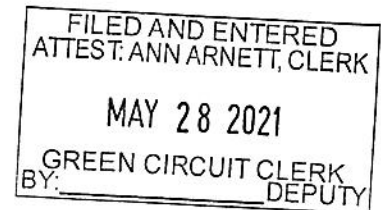


