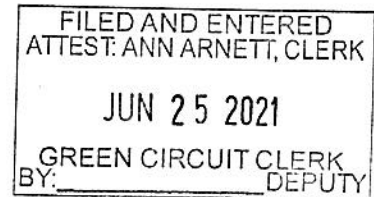

**COUNT 1:**

The Grand Jury charges that on or about March 27, 2021, in Green County, Kentucky, the above named defendant, as a pedestrian and with intent to elude or flee, knowingly or wantonly disobeyed a direction to stop given by a person recognized to be a peace officer, and at

least one (1) of the following conditions exists: the person is fleeing immediately after committing an act of domestic violence as defined in KRS 403.720; the person is driving under the influence of alcohol or any other substance or combination of substances in violation of KRS189A.010; the person is driving while his or her driver's license is suspended for violating KRS189A.010; or and by fleeing or eluding, caused or created a substantial risk of serious physical injury or death to any person or property or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 2:**

The Grand Jury charges: That on or about March 27, 2021, in Green County, Kentucky, the above-named defendant as a pedestrian, and with intent to elude or flee, the person knowingly or wantonly disobeys a direction to stop, given by a person recognized to be a peace officer who has an articulable reasonable suspicion that a crime has been committed by the person fleeing, and in fleeing or eluding the person is the cause of, or creates a substantial risk of, physical injury to any person or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 3:**

The Grand Jury charges: That on or about March 27, 2021, in Green County, Kentucky, the above-named defendant intentionally prevents or attempts to prevent a peace officer, recognized to be acting under color of his official authority, from effecting an arrest of the actor or another by using or threatening to use physical force or violence against the peace officer or another; or using any other means creating a substantial risk of causing physical injury to the peace officer or another or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 4:**

The Grand Jury charges: That on or about March 27, 2021, in Green County, Kentucky, the above-named defendant was operating a motor vehicle anywhere in this state: having an alcohol concentration of 0.08 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the influence of alcohol; while under the influence of any other substance or combination of substances which impairs one's driving ability; while the presence of a controlled substance listed in subsection (12) of this section is detected in the blood, as measured by a scientifically reliable test, or tests, taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the combined influence of alcohol and any other substance which impairs one's driving ability; or having an alcohol concentration of 0.02 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle, if the person is under the age of twenty-one (21) or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 5:**

The Grand Jury charges: That on or about March 27, 2021, in Green County, Kentucky, the above-named defendant failed to maintain required insurance or aided, abetted or counseled


with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 6:**

The Grand Jury charges: That on or about March 27, 2021, in Green County, Kentucky, the above-named defendant every motor vehicle, other than a motorcycle or moped, shall be equipped with at least two (2) headlamps with at least one (1) on each side of the front of the motor vehicle, which headlamps shall comply with the requirements and limitations set forth in this section or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 2:**

The Grand Jury charges: That on or about April 30, 2021, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed drug



paraphernalia. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 3:**

The Grand Jury charges: That on or about April 30, 2021, in Green County, Kentucky, the above-named defendant failed to register transfer of motor vehicle or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

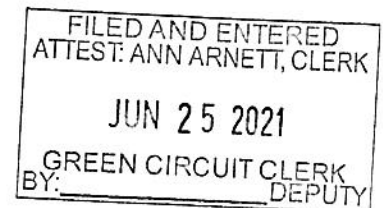

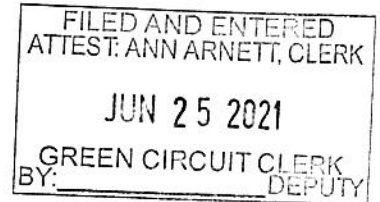

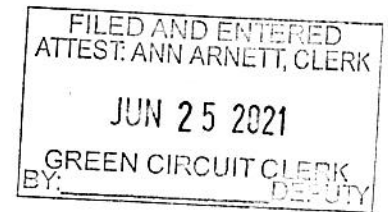

The Grand Jury charges: That on or about July 14, 2018 through April 6, 2021, in Green County, Kentucky, the above-named defendant subjects another person (KR), under the age of 12 in a continuous course of conduct, no less than two times, engaged in sexual intercourse with another person by forcible compulsion; or He engages in sexual intercourse with another person who is incapable of consent because he: is physically helpless; or is less than twelve (12) years



old or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 3:**

The Grand Jury charges that on or about April, 9, 2016 through July 13, 2018, in Green County, Kentucky, the above-named defendant subjects (KR), under the age of 12 in a continuous course of conduct, no less than two times, to sexual contact by forcible compulsion or he subjects another person to sexual contact who is incapable of consent because he or she is physically helpless; is less than twelve (12) years old or is mentally incapacitated or being twenty-one (21) years old or more, he subjects another person who is less than sixteen (16) years old to sexual contact; engages in masturbation in the presence of another person who is less than sixteen (16) years old and knows or has reason to know the other person is present; being a person in a position of authority or position of special trust, as defined in KRS 532.045, he regardless of his or her age, subjects a minor who is less than eighteen (18) years old, with whom he or she comes into contact as a result of the position, to sexual contact or engages in masturbation in the presence of the minor and knows or has reason to know the minor is present or engages in masturbation while using the internet, telephone, or other electronic communication device while communicating with a minor who the person knows is less than sixteen (16) years old, and the minor can see or hear the person masturbate or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.



The Grand Jury charges that on or about April, 9, 2016 through July 13, 2018, in Green County, Kentucky, the above-named defendant subjects (KR), under the age of 12 to sexual contact by forcible compulsion or he subjects another person to sexual contact who is incapable of consent because he or she is physically helpless; is less than twelve (12) years old or is mentally incapacitated or being twenty-one (21) years old or more, he subjects another person who is less than sixteen (16) years old to sexual contact; engages in masturbation in the presence of another person who is less than sixteen (16) years old and knows or has reason to know the other person is present; being a person in a position of authority or position of special trust, as defined in KRS 532.045, he regardless of his or her age, subjects a minor who is less than eighteen (18) years old, with whom he or she comes into contact as a result of the position, to sexual contact or engages in masturbation in the presence of the minor and knows or has reason to know the minor is present or engages in masturbation while using the internet, telephone, or other electronic communication device while communicating with a minor who the person knows is less than sixteen (16) years old, and the minor can see or hear the person masturbate or aided, abetted or counseled with another in said act.
