

federal court and has not: been granted a full pardon by the Governor or by the President of the United States; been granted relief by the United States Secretary of the Treasury pursuant to the Federal Gun Control Act of 1968, as amended or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

#### COUNT 2:

The Grand Jury charges: That on or about June 18, 2021, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed drug paraphernalia. Said act was against the peace and dignity of the Commonwealth of Kentucky.

# COUNT 3:

The Grand Jury charges: That on or about June 18, 2021, in Green County, Kentucky, the above-named defendant was operating a motor vehicle anywhere in this state: having an alcohol concentration of 0.08 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the influence of alcohol; while under the influence of any other substance or combination of substances which impairs one's driving ability; while the presence of a controlled substance listed in subsection (12) of this section is detected in the blood, as measured by a scientifically reliable test, or tests, taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the combined influence of alcohol and any other substance which impairs one's driving ability; or having an alcohol concentration of 0.02 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle, if the person is under the age of twenty-one (21)or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

#### COUNT 3:

The Grand Jury charges: That on or about June 18, 2021, in Green County, Kentucky, the above-named defendant whose operator's license has been denied, canceled, suspended or revoked, or whose privilege to operate a motor vehicle has been withdrawn, shall operate any motor vehicle upon the highways while the license is denied, canceled, suspended, or revoked or his privilege to operate a motor vehicle is withdrawn, or the license has not been applied for or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

#### COUNT 4:

The Grand Jury charges: That on or about June 18, 2021, in Green County, Kentucky the above-named defendant shall have his or her license in his or her immediate possession at all times when driving a motor vehicle and shall display it upon demand to the circuit clerk or examiner, a peace officer, a member of the Department of Kentucky State Police or a field deputy or inspector of the Department of Vehicle Regulation or Transportation Cabinet or, pursuant to KRS67A.075 or 83A.088. a safety officer who is in the process of securing information to complete an accident report or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

#### COUNT 5:

The Grand Jury charges: That on or about June 18, 2021, in Green County, Kentucky, the above-named defendant failed to produce written proof in the form of an insurance card that the insured has in effect an insurance contract providing security in conformity with this subtitle or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

The Grand Jury charges that on or about May 2020 through April 14, 2021, in Green County, Kentucky, the above-named defendant subjects another person (AM) in a continuous course of conduct, no less than two times to sexual contact by forcible compulsion or he subjects another person to sexual contact who is incapable of consent because he or she is physically helpless; is less than twelve (12) years old or is mentally incapacitated or being twenty-one (21) years old or more, he subjects another person who is less than sixteen (16) years old to sexual contact; engages in masturbation in the presence of another person who is less than sixteen (16) years old and knows or has reason to know the other person is present; engages in masturbation while using the internet, telephone, or other electronic communication device while communicating with a minor who the person knows is less than sixteen (16) years old, and the minor can see or hear the person masturbate; or being a person in a position of authority or position of special trust, as defined in KRS 532.045, he regardless of his or her age, subjects a minor who is less than eighteen (18) years old, with whom he or she comes into contact as a result of the position, to sexual contact or engages in masturbation in the presence of the minor and knows or has reason to know the minor is present or engages in masturbation

while using the internet, telephone, or other electronic communication device while communicating with a minor who the person knows is less than sixteen (16) years old, and the minor can see or hear the person masturbate or aided, abetted or counseled with another in said act. The Grand Jury charges that on or about August 2012, in Green County, Kentucky, the above-named defendant subjects another person (SR) to sexual contact by forcible compulsion or he subjects another person to sexual contact who is incapable of consent because he or she is physically helpless; is less than twelve (12) years old or is mentally incapacitated or being twenty-one (21) years old or more, he subjects another person who is less than sixteen (16) years old to sexual contact; engages in masturbation in the presence of another person who is less than sixteen (16) years old and knows or has reason to know the other person is present; engages in masturbation while using the internet, telephone, or other electronic communication device while communicating with a minor who the person knows is less than sixteen (16) years old, and the minor can see or hear the person masturbate; or being a person in a position of authority or position of special trust, as defined in KRS 532.045, he regardless of his or her age, subjects a minor who is less than eighteen (18) years old, with whom he or she comes into contact as a result of the position, to sexual contact or engages in masturbation in the presence of the minor and knows or has reason to know the minor is present or engages in masturbation while using the internet, telephone, or other electronic communication device while communicating with a minor who the person knows is less than sixteen (16) years old, and the minor can see or hear the person masturbate or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

# COUNT 21:

The Grand Jury charges that on or about August 2012 in Green County, Kentucky, the above-named defendant engages in sexual intercourse with another person (SR) who is incapable of consent because he or she is mentally retarded; being 21 years old or more he or she engages in sexual intercourse with another person less than sixteen (16) years old; being twenty-one (21) years old or more, he or she engages in sexual intercourse with another person less than eighteen (18) years old and for whom he or she provides a foster family home as defined in KRS 600.020; being a person in a position of authority or position of special trust, as defined in KRS 532.045, he or she engages in sexual intercourse with a minor under sixteen (16) years old with whom he or she comes into contact as a result of that position; being a jailer or an employee, contractor, vendor, or volunteer of the Department of Corrections Department of Juvenile Justice, or a detention facility for the custody, supervision, evaluation, or treatment of offenders, he or she subjects a person who he or she knows is incarcerated, supervised, evaluated, or treated by the Department of Corrections, Department of Juvenile Justice, detention facility, or contracting entity, to sexual intercourse or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

The Grand Jury charges: That on or about June 30, 2021, in Green County, Kentucky, the above-named defendant was operating a motor vehicle upon the highway carelessly or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

# COUNT 9:

The Grand Jury charges: That on or about June 30, 2021, in Green County, Kentucky, the above-named defendant failed to produce written proof in the form of an insurance card that the insured has in effect an insurance contract providing security in conformity with this subtitle or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

The Grand Jury charges: That on or about June 30, 2021, in Green County, Kentucky, the

above-named defendant is over the age of 21 and stood convicted of at least one felony after his 18<sup>th</sup> birthday. Said act was against the peace and dignity of the Commonwealth of Kentucky.
