**COUNTS 1-2:**

The Grand Jury charges: That on or about March 21, 2021, in Green County, Kentucky, the above-named defendant intentionally caused serious physical injury to another person; or he intentionally causes physical injury to another person by means of a deadly weapon or a dangerous instrument; or wantonly causes serious physical injury to another person by means of a deadly weapon or a dangerous instrument or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.



**COUNT 3:**

The Grand Jury charges: That on or about March 21, 2021, in Green County, Kentucky, the above-named defendant was operating a motor vehicle anywhere in this state: having an alcohol concentration of 0.08 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the influence of alcohol; while under the influence of any other substance or combination of substances which impairs one's driving ability; while the presence of a controlled substance listed in subsection (12) of this section is detected in the blood, as measured by a scientifically reliable test, or tests, taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the combined influence of alcohol and any other substance which impairs one's driving ability; or having an alcohol concentration of 0.02 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle, if the person is under the age of twenty-one (21) or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 4:**

The Grand Jury charges that on or about March 21, 2021, in Green County, Kentucky, the above-named defendant who has not applied for an operator's license or whose operator's license has been denied, canceled, suspended, or revoked, or whose privilege to operate a motor vehicle upon the highways while the license is denied, canceled, suspended, or revoked or his privilege to operate a motor vehicle is withdrawn, or the license has not been applied for or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 5**

The Grand Jury charges: That on or about March 21, 2021, in Green County, Kentucky, the above-named defendant after applying for or receiving an operator's license, moves from the address named in the application or license issued to him or when the name of a license is changed, by marriage or otherwise, the person shall within ten (10) days after the change apply to the circuit clerk in his county of residence for the issuance of a corrected license or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 6:**

The Grand Jury charges: That on or about March 21, 2021, in Green County, Kentucky, the above-named defendant operator of any vehicle upon a highway shall operate the vehicle in a careful manner, with regard for the safety and convenience of pedestrians and other vehicles upon the highway. No person shall willfully operate any vehicle on any highway in such a manner as to injure the highway aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 7:**

The Grand Jury charges: That on or about March 21, 2021, in Green County, Kentucky,


