The Grand Jury of Adair County, Kentucky, charges that on or about the 4th day of November, 2021, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant operated or was in physical control of a motor vehicle at such time as the Defendant had an alcohol concentration of 0.08 or more as measured by a scientifically reliable test or tests of a sample of the Defendant's breath or blood taken within two (2) hours of cessation of operation of physical control of a motor vehicle; or while the Defendant was under the under the influence of alcohol; or while the Defendant was under the influence of any other substance or combination of substances which impaired the Defendant's driving ability; or while the presence of a controlled substance listed in KRS 189A.010(12) was detected in the Defendant's blood, as measured by a scientifically reliable test or tests taken within two (2) hours of cessation of operation or physical control of a motor vehicle; or while the Defendant was under the combined influence of alcohol and any other substance which impairs one's driving ability, this being her second such offense within a ten (10) year period, and the Defendant refused to submit to any test or tests of her blood, breath, or urine requested by an officer having reasonable grounds to believe the Defendant was operating or in physical control of a motor vehicle in violation of Subsection (1) of this section, against the peace and dignity of the Commonwealth of Kentucky.
