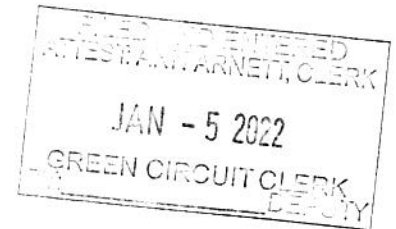

Said act was against the peace and dignity of the Commonwealth of Kentucky.

The Grand Jury charges: That on or about November 17, 2021, in Green County, Kentucky, the above-named defendant intentionally or wantonly causes physical injury to another person; or with recklessness he causes physical injury to another person by means of a deadly weapon or a dangerous instrument or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNTS 4-7:**

The Grand Jury charges: That on or about November 17, 2021, in Green County, Kentucky, the above-named defendant threaten to commit any crime likely to result in death or serious physical injury to another person or likely to result in substantial property damage to another person; or intentionally makes false statements for the purpose of causing evacuation of a building, place of assembly, or facility of public transportation or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 8:**


The Grand Jury charges: That on or about November 17, 2021, in Green County, Kentucky the above-named defendant having no right to do so or any reasonable ground to believe that he has such right, he intentionally or wantonly defaces, destroys or damages any property causing pecuniary loss of \$500 or more or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.
