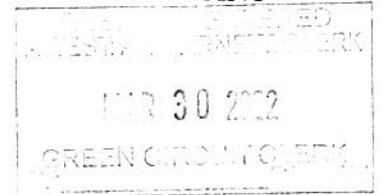

The Grand Jury charges: That on or about December 1, 2021, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed a controlled

substance classified in Schedules I or II, a narcotic drug, a controlled substance analogue; Methamphetamine; lysergic acid diethylamide; Phencyclidine; Gamma hydroxybutyric acid (GHB) including its salts, isomers, salts of isomers, and analogues; or Flunitrazepam, including its salts, isomers, and salts of isomers or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 2:

The Grand Jury charges that on or about December 1, 2021, in Green County, Kentucky, the above-named defendant under circumstances manifesting extreme indifference to the value of human life, he/she wantonly engages in conduct which creates a substantial danger of death or serious physical injury to another person or aided abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 3:

The Grand Jury charges: That on or about December 1, 2021, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed drug paraphernalia. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 4:

The Grand Jury charges that on or about December 1, 2021, in Green County, Kentucky, the above-named defendant to whom or for whose use any controlled substance has been prescribed, sold or dispensed, by a practitioner or other person authorized under this chapter, may lawfully possess it only in the container in which it was delivered to him/her by the person selling or dispensing the same or abetted or counseled with another in commission of said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 5:

The Grand Jury charges: That on or about December 1, 2021, in Green County, Kentucky, the above-named defendant after applying for or receiving an operator's license, moves from the address named in the application or license issued to him or when the name of a license is changed, by marriage or otherwise, the person shall within ten (10) days after the change apply to the circuit clerk in his county of residence for the issuance of a corrected license or aided, abetted or counseled with another in said act. The Grand Jury charges: That on or about December 1, 2021, in Green County, Kentucky, the above-named defendant failed to wear seat belt while operating a motor vehicle upon the roadway or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 7:

The Grand Jury charges: That on or about December 1, 2021, in Green County, Kentucky, the above-named defendant failed to secure a child under the age of eight (8) years who is between forty (40) inches and fifty-seven (57) inches in height in a motor vehicle operated on the roadways, streets, and highways of this state, shall have the child


properly secured in a child booster seat or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 5:

The Grand Jury charges that on or about October 16, 2021, in Green County, Kentucky, the above-named defendant was operating a motor vehicle anywhere in this state: having an alcohol concentration of 0.08 or more as measured by a scientifically reliable test or tests of a

sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the influence of alcohol; while under the influence of any other substance or combination of substances which impairs one's driving ability; while the presence of a controlled substance listed in subsection (12) of this section is detected in the blood, as measured by a scientifically reliable test, or tests, taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the combined influence of alcohol and any other substance which impairs one's driving ability; or having an alcohol concentration of 0.02 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle, if the person is under the age of twenty-one (21) or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 6:

The Grand Jury charges that on or about October 16, 2021, in Green County, Kentucky, the above-named defendant was operating a motor vehicle and transporting a child of forty (40) inches in height or less in a motor vehicle operated on the roadways, streets, and highways of this state, shall have the child properly secured in a child restraint system of a type meeting federal motor vehicle safety standards or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 7:

The Grand Jury charges: That on or about October 16, 2021, in Green County, Kentucky, the above-named defendant failed to wear seat belt while operating a motor vehicle upon the roadway or aided, abetted or counseled with another in said act. The Grand Jury charges: That on or about January 11, 2022, in Green County, Kentucky, the above-named defendant by use of physical force or a threat directed to a person he believes to be a participant in the legal process, he or she: Influences or attempts to influence, the testimony, vote, decision, or opinion of that person; Induces or attempts to induce, that person to avoid legal process summoning him or her to testify; Induces, or attempts to induce, that person to absent himself or herself from an official proceeding to which he has been legally summoned; Induces or attempts to induce, that person to withhold a record, document, or other object from an official proceeding; Induces, or attempts to induce, that person to alter, destroy, mutilate, or conceal an object with intent to impair the object's integrity or availability for use in an official proceeding; or Hinders delays, or prevents the communication to a law enforcement officer or judge of information relating to the possible commission of an offense or a violation of conditions of probation, parole or release pending judicial proceedings or aided, abetted or counseled with another in said act. 

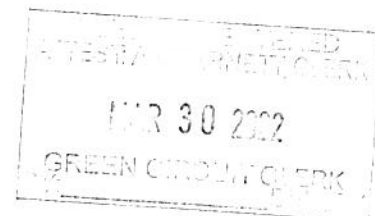

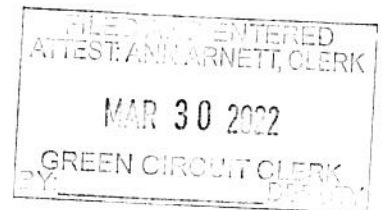

The Grand Jury charges: That on or about February 11, 2022, in Green County, Kentucky, the above-named defendant knowingly and unlawfully restrained another person under circumstances which exposed that person to a risk of serious physical injury or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 3:

The Grand Jury charges: That on or about February 11, 2022, in Green County, Kentucky, the above-named defendant under circumstances manifesting extreme indifference to the value of human life, he/she wantonly engages in conduct which creates a substantial danger of death or serious physical injury to another person or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 4:

The Grand Jury charges: That on or about February 11, 2022, in Green County, Kentucky, the above-named unlawfully took or exercised control over movable property of another, with intent to deprive another thereof, (valued **Under 1,000.00**), **OR** obtained immovable property of another with intent to deprive another thereof **OR** obtained immovable property of another or any interest therein with intent to benefit himself or another not entitled thereto **OR** aided, abetted or counselled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 5:

The Grand Jury charges: That on or about February 11, 2022, in Green County, Kentucky, the above-named defendant intentionally or wantonly causes physical injury to another person; or with recklessness he causes physical injury to another person by means of a deadly weapon or a dangerous instrument or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 6:

The Grand Jury charges: That on or about February 11, 2022, in Green County, Kentucky, the above-named defendant having no right to do so or any reasonable ground to believe that he has such a right, he intentionally or wantonly defaces, destroys, or damages any property causing pecuniary loss under \$500 or more or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 7:

The Grand Jury charges: That on or about February 11, 2022, in Green County, Kentucky the above-named defendant having no right to do so or any reasonable ground to believe that he has such right, he intentionally or wantonly defaces, destroys or damages any property (Home-Value over 1,000) or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 8:


The Grand Jury charges: That on or about February 11, 2022, in Green County, Kentucky, the above-named defendant threaten to commit any crime likely to result in death or serious physical injury to another person or likely to result in substantial property damage to another person; or intentionally makes false statements for the purpose of causing evacuation of a building, place of assembly, or facility of public transportation or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.
