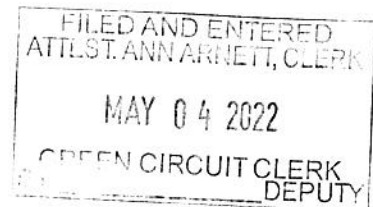

The Grand Jury charges: That on or about February 13, 2022, in Green County, Kentucky, the above-named defendant recklessly, with a deadly weapon or dangerous instrument, or intentionally causes or attempts to cause physical injury to: a state, county, city, or federal peace officer or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 2:**

The Grand Jury charges: That on or about February 13, 2022, in Green County, Kentucky, the above-named defendant intentionally prevents or attempts to prevent a peace officer, recognized to be acting under color of his official authority from effecting an arrest of the actor or another by: using or threatening to use physical force or violence against the peace officer or another; or using any other means creating a substantial risk of causing physical injury to the peace officer or another or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 3:**

The Grand Jury charges: That on or about February 13, 2022, in Green County, Kentucky, the above-named defendant wantonly engages in conduct which creates a substantial danger of physical injury to another person or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 4:**

The Grand Jury charges: That on or about February 13, 2022, in Green County, Kentucky, the above-named defendant intentionally placed another person in reasonable apprehension of imminent physical injury or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 5:**

The Grand Jury charges that on or about February 13, 2022, in Green County, Kentucky, the above-named defendant appears in a public place manifestly under the influence of a controlled substance, or other intoxicating substance, excluding alcohol (unless the alcohol is present in combination with any of the above), not therapeutically administered, to the degree that he may endanger himself or other persons or property, or unreasonably annoy person in his vicinity or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 6:**


The Grand Jury charges: That on or about February 13, 2022, in Green County, Kentucky, the above-named defendant when he or she: in a public place and with intent to cause public inconvenience, annoyance, or alarm, or wantonly creating a risk thereof: engages in fighting or in violent, tumultuous, or threatening behavior; make unreasonable noise; or refuses to obey an official order to disperse issued to maintain public safety in dangerous proximity to a fire, hazard, or other emergency; or creates a hazardous or physically offensive condition by any act that serves no legitimate purpose or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

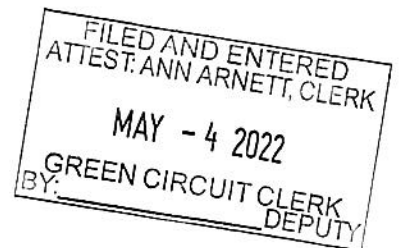

The Grand Jury charges: That on or about March 5, 2022, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed a controlled substance classified in Schedules I or II, a narcotic drug, this is the second offense or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 3:**

The Grand Jury charges: That on or about March 5, 2022, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed drug paraphernalia. Said act was against the peace and dignity of the Commonwealth of Kentucky.

The Grand Jury charges: That on or about March 5, 2022, in Green County, Kentucky, the above-named defendant was operating a motor vehicle anywhere in this state: having an alcohol concentration of 0.08 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the influence of alcohol; while under the influence of any other substance or combination of substances which impairs one's driving ability; while the presence of a controlled substance listed in subsection (12) of this section is detected in the blood, as measured by a scientifically reliable test, or tests, taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the combined influence of alcohol and any other substance which impairs one's driving ability; or having an alcohol concentration of 0.02 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle, if the person is under the age of twenty-one (21) or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 5:**

The Grand Jury charges that on or about March 5, 2022, in Green County, Kentucky, the above-named defendant to whom or for whose use any controlled substance has been prescribed, sold or dispensed, by a practitioner or other person authorized under this chapter, may lawfully possess it only in the container in which it was delivered to him/her by the person selling or dispensing the same or abetted or counseled with another in commission of said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 6:**

**COUNT 5:**

The Grand Jury charges: That on or about November 19, 2021, in Green County, Kentucky, the above-named defendant threaten to commit any crime likely to result in death or serious physical injury to another person or likely to result in substantial property damage to another person; or intentionally makes false statements for the purpose of causing evacuation of a building, place of assembly, or facility of public transportation or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 7:**

The Grand Jury charges: That on or about November 19, 2021, in Green County, Kentucky, the above-named defendant in a public place and with intent to cause public inconvenience, annoyance, or alarm, or wantonly creating a risk thereof: Engages in fighting or in violent, tumultuous, or threatening behavior; makes unreasonable noise; or creates a hazardous

or physically offensive condition by any act that serves no legitimate purpose; and acts in a way described in paragraph (a) of this subsection within three hundred (300) feet of a: cemetery during a funeral or burial; funeral home during the viewing of a deceased person; Funeral procession; Funeral or memorial service; or building in which a funeral or memorial service is being conducted; or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 8:**

The Grand Jury charges: That on or about November 19, 2021, in Green County, Kentucky, the above-named defendant intentionally prevents or attempts to prevent a peace officer, recognized to be acting under color of his official authority from effecting an arrest of the actor or another by: using or threatening to use physical force or violence against the peace officer or another; or using any other means creating a substantial risk of causing physical injury to the peace office or another or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 9:**


The Grand Jury charges: That on or about November 19, 2021, in Green County, Kentucky, the above-named defendant was operating a motor vehicle anywhere in this state: having an alcohol concentration of 0.08 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the influence of alcohol; while under the influence of any other substance or combination of substances which impairs one's driving ability; while the presence of a controlled substance listed in subsection (12) of this section is detected in the blood, as measured by a scientifically reliable test, or tests, taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the combined influence of alcohol and any other substance which impairs one's driving ability; or having an alcohol concentration of 0.02 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle, if the person is under the age of twenty-one (21) or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 10:**

The Grand Jury charges: That on or about November 19, 2021, in Green County, Kentucky, the above-named defendant was operating a motor vehicle upon the highway carelessly or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

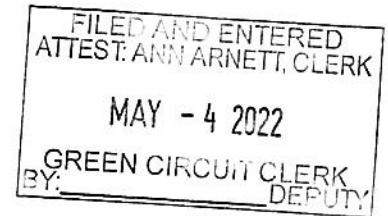


