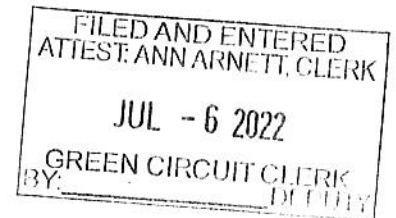



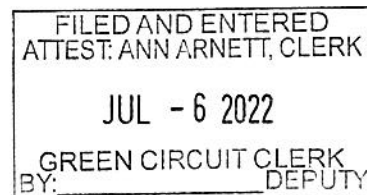

COUNTS 1-2:

March 16, 2022 -

The Grand Jury charges: That on or about March 29, 2022, in Green County, Kentucky the above-named defendant by use of physical force or threat directed to a witness or person he/she believes will be a participant in the legal process, see text above; influence, or attempt to influence, his testimony, vote, decision, or opinion; induce, or attempt to induce the legal participant to avoid legal process summoning him or her to testify, or to absent himself or herself from an official proceeding to which he has been legally summoned, or to withhold a record, document, or other object from an official proceeding or induce or attempt to induce, the legal participant to alter, destroy, mutilate, or conceal an object with intent to impair the object's integrity or a availability for use in an official proceeding or hinder, delay or prevent the communication to a law enforcement officer or judge of information relating to the possible commission of an offense or a violation of conditions of probation, parole, or release pending judicial proceedings or aided, abetted or counseled with another is said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 3:

March 16, 2022 -

The Grand Jury charges: That on or about March 29, 2022, in Green County, Kentucky the above-named defendant knowingly that a person is or may be called as a witness in an official proceeding, he: induced or attempts to induce the witness to absent himself or otherwise avoid appearing or testifying at the official proceeding with intent to influence the outcome thereby; or knowingly make any false statements or practices any fraud or deceit with intent to


affect the testimony of the witness or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.
