intercourse with a minor under eighteen (18) years old with whom he or she comes into contact as a result of that position; being a jailer or an employee, contractor, vendor, or volunteer of the Department of Corrections Department of Juvenile Justice, or a detention facility for the custody, supervision, evaluation, or treatment of offenders, he or she subjects a person who he or she knows is incarcerated, supervised, evaluated, or treated by the Department of Corrections, Department of Juvenile Justice, detention facility, or contracting entity, to sexual intercourse or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNTS 9-11:

The Grand Jury charges that on or about October 19, 2020 through May 7, 2022, in Green County, Kentucky, the above-named defendant being twenty-one (21) years old or more, he or she engages in deviate sexual intercourse with another person less than sixteen (16) years old; Being at least ten (10) years older than a person who is sixteen (16) or seventeen (17) years old at the time of deviate sexual intercourse, he or she engages in deviate sexual intercourse with the person; Being twenty-one (21) years old or more, he or she engages in deviate sexual intercourse with another person less than eighteen (18) years old and for whom he or she provides a foster family home as defined in KRS 600.020; Being a person in a position of authority or position of special trust, as defined in KRS 532.045, he or she engages in deviate sexual intercourse with a minor less than eighteen (18) years old with whom he or she comes into contact as a result of that position; or Being a jailer, or an employee, contractor, vendor, or volunteer of the Department of Corrections, Department of Juvenile Justice, or a detention facility as defined in KRS 520.010, or of an entity under contract with either department or a detention facility for the custody, supervision, evaluation, or treatment of offenders, he or she subjects a person who he or she knows is incarcerated, supervised, evaluated, or treated by the Department of Corrections, Department of Juvenile Justice, detention facility, or contracting entity, to deviate sexual intercourse or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNTS 12-14:

The Grand Jury charges that on or about October 19, 2020 through May 7, 2022, in Green County, Kentucky, the above-named defendant subjects (KR), under the age of 12 in a continuous course of conduct, no less than two times, to sexual contact by forcible compulsion or he subjects another person to sexual contact who is incapable of consent because he or she is physically helpless; is less than twelve (12) years old or is mentally incapacitated or being twenty-one (21 years old or more, he subjects another person who is less than sixteen (16) years old to sexual contact; engages in masturbation in the presence of another person who is less than sixteen (16) years old and knows or has reason to know the other person is present; being a person in a position of authority or position of special trust, as defined in KRS 532.045, he regardless of his or her age, subjects a minor who is less than eighteen (18) years old, with whom he or she comes into contact as a result of the position, to sexual contact or engages in masturbation in the presence of the minor and knows or has reason to know the minor is present or engages in masturbation while using the internet, telephone, or other electronic communication device while communicating with a minor who the person knows is less than sixteen (16) years old, and the minor can see or hear the person masturbate or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the

Commonwealth of Kentucky.

COUNTS 15-22:
