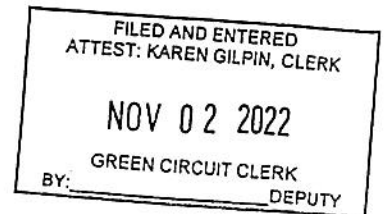

The Grand Jury charges that on or about May 2, 2022, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed a controlled substance that is classified as a Schedule I or II, (**Methamphetamine**) which is a narcotic drug, this is the second offense, or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 2:

The Grand Jury charges that on or about May 2, 2022, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed a controlled substance that is



classified as a Schedule I or II, (**Hydrocodone**) which is a narcotic drug, this is the second offense, or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

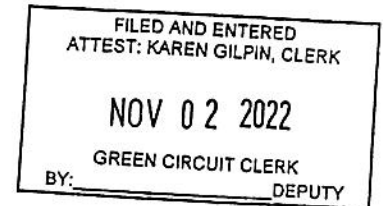

COUNTS 1-3:

The Grand Jury charges that on or about August 18, 2022, in Green County, Kentucky, the above-named defendant under circumstances manifesting extreme indifference to the value of human life, he wantonly engages in conduct which creates a substantial danger of death or serious physical injury to another person or aided abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 4:

The Grand Jury charges: That on or about August 18, 2022, in Green County, Kentucky, the above-named defendant while operating a motor vehicle with intent to elude or flee, the person knowingly or wantonly disobeys a direction to stop his or her motor vehicle, given by a person recognized to be a police officer and at least (1) of the following conditions exists: the person is fleeing immediately after committing and act of domestic violence as defined in KRS 403.720 the person is driving under the influence of alcohol or any other substance or combination of substance in violation of KRS 189A.010; the person is driving while his or her driver's license is suspended for violating KRS 189A.010; or be fleeing or eluding, the person is the cause, or creates substantial risk, of serious physical injury or death of any person or property; or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 5:

The Grand Jury charges that on or about August 18, 2022, in Green County, Kentucky, the above-named defendant who has not applied for an operator's license or whose operator's license has been denied, canceled, suspended, or revoked, or whose privilege to operate a motor vehicle upon the highways while the license is denied, canceled, suspended, or revoked or his privilege to operate a motor vehicle is withdrawn, or the license has not been applied for or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 6:

The Grand Jury charges: That on or about August 18, 2022, in Green County, Kentucky, the above-named defendant was operating a vehicle upon a highway at a greater speed than is reasonable and prudent, having no regard for the traffic and for the condition and use of the highway or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 7:

The Grand Jury charges: That on or about August 18, 2022, in Green County, Kentucky, the above-named defendant operator of any vehicle upon a highway shall operate the vehicle in a careful manner, with regard for the safety and convenience of pedestrians and other vehicles upon the highway. No person shall willfully operate any vehicle on any highway in such a manner as to injure the highway aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 8:

The Grand Jury charges that on or about August 18, 2022, in Green County, Kentucky,

the above-named defendant failed to stop at stop signs or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNTS 9-10:

The Grand Jury charges that on or about August 18, 2022, in Green County, Kentucky, the above-name defendant was operating a motor vehicle and failed to give signal or proper signal or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 11:


The Grand Jury charges: That on or about August 18, 2022, in Green County, Kentucky, the above-named defendant shall not drive on the left side of the roadway under the following conditions: When approaching or upon the crest of a grade or a curve in the highway where the operator's view is obstructed within such distance as to create a hazard in the event another vehicle might approach from the opposite direction; When approaching within one hundred (100) feet of or traversing any intersection or railroad grade crossing; When the view is obstructed upon approaching within one hundred (100) feet of any bridge, viaduct or tunnel; The foregoing limitations shall not apply upon a one (1) way roadway, nor when an obstruction exists making it necessary to drive to the left of the center of the highway; provided, any person doing so shall yield the right of way to all vehicles traveling in the proper direction upon the unobstructed portion of the highway within such distance as to constitute an immediate hazard, nor to the operator of a vehicle turning left into or from an alley, private road or driveway or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 12:


The Grand Jury charges: That on or about August 18, 2022, in Green County, Kentucky, the above-named defendant is over the age of 21 and stood convicted of at least two felonies after his 18th birthday **OR** one (1) or more felony sex crimes against a minor as defined in KRS 17.500, and now stands convicted of any one (1) or more felonies. Said act was against the peace and dignity of the Commonwealth of Kentucky.

Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 2:

The Grand Jury charges that on or about July 19, 2022, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed drug paraphernalia or aided, abetted or counseled with another in said act. Said act against the peace and dignity of the Commonwealth of Kentucky.

COUNT 3:

The Grand Jury charges: That on or about July 19, 2022, in Green County, Kentucky, the above-named defendant whose operator's license has been denied, canceled, suspended or revoked, or whose privilege to operate a motor vehicle has been withdrawn, shall operate any motor vehicle upon the highways while the license is denied, canceled, suspended, or revoked or his privilege to operate a motor vehicle is withdrawn, or the license has not been applied for or aided, abetted or counseled with another in said act. COUNT 5:

The Grand Jury charges: That on or about August 9, 2022, in Green County, Kentucky, the above-named defendant after applying for or receiving an operator's license, moves from the address named in the application or license issued to him or when the name of a license is changed, by marriage or otherwise, the person shall within ten (10) days after the change apply to the circuit clerk in his county of residence for the issuance of a corrected license or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 6:

The Grand Jury charges: That on or about August 9, 2022, in Green County, Kentucky, the above-named defendant was operating a vehicle upon a highway at a greater speed than is reasonable and prudent, having no regard for the traffic and for the condition and use of the highway or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 7:

The Grand Jury charges: That on or about August 9, 2022, in Green County, Kentucky,

the above-named defendant shall not operate a motorcycle on a highway: expect when that person is in possession of a valid motorcycle operator's license; and unless that person uses an approved eye-protective device, in the manner prescribed by the secretary of the transportation cabinet, at all times such vehicle is in motion and unless the motorcycle is equipped with a rear-view mirror as required under KRS 189.130 or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 8:

The Grand Jury charges that on or about August 9, 2022, in Green County, Kentucky, the above-name defendant was operating a motor vehicle and filed to give signal or proper signal or aided, abetted or counseled with another in said act. 
