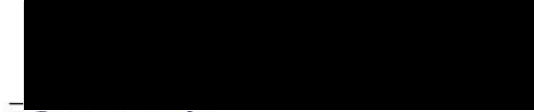

COUNT 2:

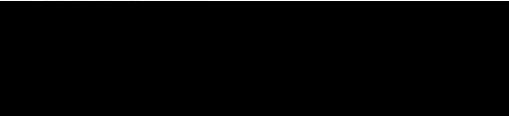


