

COUNT 1:

The Grand Jury charges: That on or about October 27, 2022, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed a controlled substance classified in Schedules I or II, a narcotic drug, a controlled substance analogue; Methamphetamine; lysergic acid diethylamide; Phencyclidine; Gamma hydroxybutyric acid (GHB) including its salts, isomers, salts of isomers, and analogues; or Flunitrazepam, including its salts, isomers, and salts of isomers or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 2:

The Grand Jury charges that on or about October 27, 2022, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed drug paraphernalia or aided, abetted or counseled with another in said act. Said act against the peace and dignity of the Commonwealth of Kentucky.

COUNT 3:

The Grand Jury charges: That on or about October 27, 2022, in Green County, Kentucky, the above-named defendant: (a) In a public place and with intent to cause public inconvenience, annoyance, or alarm, or wantonly creating a risk thereof: 1. Engages in fighting or in violent, tumultuous, or threatening behavior; 2. Makes unreasonable noise; or 3. Creates a hazardous or physically offensive condition by any act that serves no legitimate purpose; and (b) Acts in a way described in paragraph (a) of this subsection within three hundred (300) feet of a: 1. Cemetery during a funeral or burial; 2. Funeral home during the viewing of a deceased person; 3. Funeral procession; 4. Funeral or memorial service; or 5. Building in which a funeral or memorial service is being conducted; and (c) Acts in a way described in paragraph (a) of this subsection at any point in time between one (1) hour prior to the commencement of an event specified in paragraph (b) of this subsection and one (1) hour following its conclusion; and (d) Knows that he or she is within three hundred (300) feet of an occasion described in paragraph (b) of this subsection. or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 4:-5

The Grand Jury charges: That on or about October 27, 2022, in Green County, Kentucky, the above-named defendant threatens to commit any crime likely to result in death or serious physical injury to another person or likely to result in substantial property damage to another person or intentionally makes false statement for the purpose

of causing evacuation of a building, place of assembly, or facility of public transportation or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT &

The Grand Jury charges: That on or about October 27, 2022, in Green County, Kentucky, the above-named defendant was operating a motor vehicle upon a highway and had failed to maintain required insurance or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 7

The Grand Jury charges that on or about October 27, 2022, in Green County, Kentucky, the above-named defendant was operating a motor vehicle anywhere in this state: having an alcohol concentration of 0.08 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the influence of alcohol; while under the influence of any other substance or combination of substances which impairs one's driving ability; while the presence of a controlled substance listed in subsection (12) of this section is detected in the blood, as measured by a scientifically reliable test, or tests, taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the combined influence of alcohol and any other substance which impairs one's driving ability; or having an alcohol concentration of 0.02 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle, if the person is under the age of twentyone (21)or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 8

The Grand Jury charges that on or about October 27, 2022, in Green County, Kentucky, the above-named defendant failed before operating a motor vehicle, motorcycle, or moped upon a highway, secured an operator's license or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 9

The Grand Jury charges: That on or about October 27, 2022, in Green County, Kentucky, the above-named defendant failed to have rear license plate illuminated or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT YO

The Grand Jury charges: That on or about October 27, 2022, in Green County, Kentucky, the above-named defendant improperly displayed the registration plate or aided, abetted, or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 1/

The Grand Jury charges that on or about October 27, 2022, in Green County,

Kentucky, the above-named defendant failed to have registration plate conspicuously upon the rear of the motor vehicle or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 12

The Grand Jury charges that on or about October 27, 2022, in Green County, Kentucky, the above-named defendant failed to have the receipt issued by the cabinet through the county clerk constantly in his possession or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 13

The Grand Jury charges: That on or about October 27, 2022, in Green County, Kentucky, the above-named defendant failed to produce written proof in the form of an insurance card that the insured has in effect an insurance contract providing security in conformity with this subtitle or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 14

The Grand Jury charges: That on or about October 27, 2022, in Green County, Kentucky, the above-named defendant failed to wear seat belt while operating a motor vehicle upon the roadway or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

Flunitrazepam, including its salts, isomers, and salts of isomers or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 2:

The Grand Jury charges that on or about November 7, 2022, in Green County, Kentucky, the above-named defendant under circumstances manifesting extreme indifference to the value of human life, he wantonly engages in conduct which creates a substantial danger of death or serious physical injury to another person or aided abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 3:

The Grand Jury charges that on or about November 7, 2022, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed drug paraphernalia or aided, abetted or counseled with another in said act. Said act against the peace and dignity of the Commonwealth of Kentucky.

COUNT 4:

The Grand Jury charges that on or about November 7, 2022, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possesses a controlled substance classified in schedules IV or V or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNTS 5-7:

The Grand Jury charges: That on or about November 7, 2022, in Green County, Kentucky the above-named defendant possessed a legend drug or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 8:

The Grand Jury charges that on or about November 7, 2022, in Green County, Kentucky, the above-named defendant to whom or for whose use any controlled substance has been prescribed, sold or dispensed, by a practitioner or other person authorized under this chapter, may lawfully possess it only in the container in which it was delivered to him/her by the person selling or dispensing the same or abetted or counseled with another in commission of said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 9:
