intentionally causes or attempts to cause physical injury to: a state, county, city, or federal peace officer or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 3:

The Grand Jury charges: That on or about April 11, 2023, in Green County, Kentucky, the above-named defendant escapes from a detention facility or being charged with or convicted of a felony, escapes from custody or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 4:

The Grand Jury charges that on or about April 11, 2023, in Green County, Kentucky, the above-named defendant as a pedestrian, and with intent to elude or flee, the person knowingly or wantonly disobeys a direction to stop, given by a person recognized to be a peace officer who has an articulable reasonable suspicion that a crime has been committed by the person fleeing and in fleeing or eluding the person is the cause of, or creates a substantial risk of physical injury to any person or aided, abetted or counseled with another is said act. Said act was against the peace and dignity of the Commonwealth.

COUNT 5:

The Grand Jury charges: That on or about April 11, 2023, in Green County, Kentucky, the above-named defendant after applying for or receiving an operator's license, moves from the address named in the application or license issued to him or when the name of a license is changed, by marriage or otherwise, the person shall within ten (10) days after the change apply to the circuit clerk in his county of residence for the issuance of a corrected license or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 6:

The Grand Jury charges: That on or about April 11, 2023, in Green County, Kentucky, the above-named defendant when he or she: in a public place and with intent to cause public inconvenience, annoyance, or alarm, or wantonly creating a risk thereof: engages in fighting or in violent, tumultuous, or threatening behavior; make unreasonable noise; or refuses to obey an official order to disperse issued to maintain public safety in dangerous proximity to a fire, hazard, or other emergency; or creates a hazardous or physically offensive condition by any act that serves no legitimate purpose or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 7:

The Grand Jury charges that on or about April 11, 2023, in Green County, Kentucky, the above-named defendant was operating a motor vehicle anywhere in this state: having an alcohol concentration of 0.08 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the influence of alcohol; while under the influence of any other substance or combination of substances which impairs one's driving ability; while the presence of a controlled substance listed in subsection (12) of this section is detected in the

blood, as measured by a scientifically reliable test, or tests, taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the combined influence of alcohol and any other substance which impairs one's driving ability; or having an alcohol concentration of 0.02 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle, if the person is under the age of twenty-one (21)or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNTS 8-14:

The Grand Jury charges: That on or about April 11, 2023, in Green County, Kentucky, the above-named defendant engaged or agrees or offers to engage in sexual conduct with another person in return for a fee or aided, abetted or counseled with another in said act.
