COUNT 4:

The Grand Jury of Adair County, Kentucky, charges that on or about June 18, 2024, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant knowingly and unlawfully possessed or used any current or former identifying information of another person, with the intent to represent that he was the other person for the purpose of depriving the other person of property, or for the purpose of obtaining benefits or property to which he would otherwise not be entitled, or for the purpose of making financial or credit transactions using the other person's identity, or for the purpose of avoiding detection, or for the purpose of commercial or political benefit, against the peace and dignity of the Commonwealth of Kentucky.

COUNT 5:

The Grand Jury of Adair County, Kentucky, charges that on or about June 18, 2024, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant committed the offense of Theft of Identity, contrary to KRS 514.160, and at that time the defendant was a person more than twenty-one (21) years of age, who stood convicted of at least two (2) prior felony offenses, with the previous convictions being convictions of felonies in this state or convicted of crimes in any other jurisdiction, and that a sentence to a term of imprisonment of one (1) year or more was imposed therefore, and the defendant was over the age of eighteen (18) years at the time the offenses were committed and the defendant completed the service of the sentence imposed on at least one (1) of the previous felony convictions within five (5) years prior to the date of June 18, 2024, or the defendant was on probation, parole, conditional discharge, conditional release, furlough, appeal bond, or any other form of legal release from any of the previous felony convictions at the date of June 18, 2024, or the defendant was discharged from probation, parole, conditional discharge, conditional release, or any other form of legal release on any of the previous felony convictions within five (5) years prior to the date of June 18, 2024, against the peace and dignity of the Commonwealth of Kentucky.
