The Grand Jury of Adair County, Kentucky, charges that on or about May 12<sup>th</sup> – 30<sup>th</sup>, 2024, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant having been convicted of a "sex-crime" as such term is defined in KRS 17.500(6), he resided at a location prohibited by KRS 17.545, this being a first such offense, against the peace and dignity of the Commonwealth of Kentucky.

#### COUNT 2:

The Grand Jury of Adair County, Kentucky, charges that on or about May 12<sup>th</sup> – 30<sup>th</sup>, 2024, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant having been convicted of a "sex-crime" as such term is defined in KRS 17.500(6), he knowingly and unlawfully failed to notify the appropriate local probation and parole office of a change in his residence address, in violation of KRS 17.510, or he otherwise failed to comply with any provisions of the Kentucky Sex Offender Registration requirements set forth in KRS 17.510, this being a first such offense, against the peace and dignity of the Commonwealth of Kentucky.

# COUNT 3:

The Grand Jury of Adair County, Kentucky, charges that on or about May 12<sup>th</sup> – 30<sup>th</sup>, 2024, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant committed the offense of Failure to Comply with Sex Offender Registration, contrary to KRS 17.5[10(11), and at that time the defendant was a person more than twenty-one (21) years of age, who stood convicted of a prior felony offense, with the previous conviction being a conviction of a felony in this state or convicted of a crime in any other jurisdiction, and that a sentence to a term of imprisonment of one (1) year or more was imposed therefore, and the defendant was over the age of eighteen (18) years at the time the offense was committed and the defendant completed the service of the sentence imposed on the previous felony conviction within five (5) years prior to the date(s) of May 12<sup>th</sup> - 30<sup>th</sup>, 2024, or the defendant was on probation, parole, conditional discharge, conditional release, furlough, appeal bond, or any other form of legal release from the previous felony conviction at the date(s) of May 12<sup>th</sup> - 30<sup>th</sup>, 2024, or the defendant was discharged from probation, parole, conditional discharge, conditional release, or any other form of legal release on the previous felony conviction within five (5) years prior to the date(s) of May  $12^{th} - 30^{th}$ , 2024, against the peace and dignity of the Commonwealth of Kentucky.
