believed to be suboxone mixed with fentanyl; two (2) folded pieces of paper filled with a powder substance believed to be suboxone mixed with fentanyl; and four (4) commissary Kool-Aid packets filled with a powder substance believed to be suboxone mixed with fentanyl, same being dangerous contraband, into the Adair County Regional Jail, or being a person confined in the Adair County Regional Jail, he knowingly made, obtained, or possessed a small magnet, and a cellophane wrapper which contained: two (2) marijuana cigarettes; one (1) cellophane wrapper filled with a powder substance believed to be suboxone mixed with fentanyl; two (2) folded pieces of paper filled with a powder substance believed to be suboxone mixed with fentanyl; and four (4) commissary Kool-Aid packets filled with a powder substance believed to be suboxone mixed with fentanyl, same being dangerous contraband, against the peace and dignity of the Commonwealth of Kentucky.

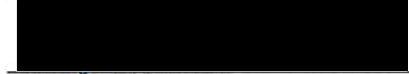
